GENERAL AVIATION REPORT ISSUE

On a recent visit to Lydd for lunch, I was stopped by some UK Border Force officers who wanted to promote the online submission of General Aviation Reports, which I'm sure you all know are now legally required to submit not less than 4 hours before the planned arrival time — even when arriving at a fully staffed Designated Airport of Entry! We had a discussion as to why this was required at such airports, but clearly the legislators have their own agenda and have decided that they wanted a system that was the same across the board. They made it very clear, both verbally, and in the supplied brochure, that the online system would eventually be the only acceptable means of submission

On my return, I then visited the promoted Online GAR service and attempted to complete a GAR for a future flight. I aborted this upon finding out that they expected me to pay for this according to a table depending on passenger numbers etc. As is my way, I emailed the UK Border Authority explaining that I was not prepared to use their service with this charge, and would continue to only use Designated Airports where I would file by fax as I always had done. I explained that charging us for a service that actually wasn't really necessary at a Designated Airport of Entry was little more than yet another stealth tax on general aviation, and one that I wouldn't accept.

Their direct and reasonably quick response was as follows:

It was me that gave the presentation at Lydd, and since then there have been some changes, with a commercial venture providing an enhanced service for a fee, but a free service is still available - see options below.

GAR (General Aviation Report) information can be submitted to Border Force in the following ways:-

Online submission via:-

www.AOPA.co.uk - the online GAR is accessed via a grey button. This is a FREE service available to all (not just AOPA members).

The old link to the original AOPA online system is no longer valid.

www.onlinegar.com - this is a commercial service that provides enhanced functionality. Although it is a paid service, on registration free credits are provided. Free access is also provided by online flight planning providers such as Skydemon depending on their subscription package.
