### **TONY CROOK**

It is regret that I advise that old Biggin Hill'ite Anthony (Tony) Crook passed away on the 21<sup>st</sup> January 2014 – a private funeral was held on 3<sup>rd</sup> February. Former RAF wartime bomber pilot and ex Racing Driver Tony's full story featured in the May 2013 edition of the Biggin Hill Bugle (viewable online under 'Back Issues' – <a href="https://www.bigginhillclub.co.uk/may2013.pdf">www.bigginhillclub.co.uk/may2013.pdf</a>).

He was the owner of the Bristol car company for many years with the workshop at Bristol Airport. These were hand built cars right down to the body work, which was made of aluminium. He owned three Rallye aircraft during his time at Biggin Hill and still had one, which is kept at Denham.

Tony died peacefully in his sleep just short of 94.

Great News for the local community and the airport, most of whom have missed their annual air show. It will not be the same type of show as the Air Fair, but I am sure, with the airport behind it and with Colin Hitchins (formerly the organiser of the Air Fair) involved, I'm sure it will be an event not to be missed.

#### **FARNBOROUGH**

It does seem that Farnborough Airport in Hampshire is seeking to shut off a major part of the South East of the UK to Light Aviation to cope with their now approved increase in aircraft movements. Their complex plans are published in a consultation document that any interested parties may participate in. The shut off point for submissions under this consultation is 23:00 on Friday 2<sup>nd</sup> May 2014.

I have read through it very briefly and my initial concern (apart from the complexity and MASSIVE size) is the proposed Radio Mandatory Zone that appears to all but shut off the end of the corridor between the Gatwick and Heathrow zones to all non-radio and non-transponder equipped aircraft. Whilst I don't personally fly aircraft in that category, I would be concerned if that category of GA was affected in that manner. Other than that, the plans, which do appear ridiculously and unnecessarily complex, in the main, do not seem to affect much airspace below 2,500ft (if one has radio!). There are also a couple of minor plus points for GA in the plans

I really think that anyone who ever flies in this part of the UK should read these plans and make your views known, while you have time. This continued growth of Controlled Airspace needs to be carefully monitored before the UK becomes one big control zone. And to TAG who are seeking this airspace – who do you think you are? There are airports around the world a hundred times more complex and with massively more traffic than you will ever have, operating without a fraction of the restrictions and airspace that you seem to want to have control of!!

## ANOTHER COUP FOR BIGGIN HILL AIRPORT

Just in as we were about to publish this Newsletter – hot off the press – it has been announced that Orlando based Signature Flight Support has acquired the Fixed Base Operations (FBO) part of Jets Ltd of Biggin Hill. #### MONTHLY REPORT FROM THE OFFICE OF WILL CURTIS

February has been another wet month, but fortunately we have been able to remain open for business throughout. Private flying and training has benefitted from a few days of decent weather and probably as many as can be expected in February. We were busy with corporate jets over the half term period as many took advantage of the improved snow conditions in the Alps. BHAL is currently recruiting Passenger Handling Staff. Interested parties can find out more about this opportunity via the BHAL website. We want to offer the jobs to local residents so please prompt any suitable candidates you may know to apply!

The Biggin Hill Festival of Flight has now been formally announced and will place on Saturday 14<sup>th</sup> June 2014. The event this year will celebrate the 50th anniversary of the formation of the Red Arrows, who will fly at Biggin Hill that day. Tickets will be on sale via local shops and online from mid-March. We expect tickets to sell out quickly and the event must be limited to 15,000 spectators due to Health and Safety considerations, so if you want to attend please make sure you get your tickets early! The airfield will be substantially open for normal operations during the day of the event. We will have only three hours or so of actual display flying split into two or three blocks in order to allow normal air traffic outside these times. An ATC OPS notice will be published soon regarding flying on that day. Apart from these minimal restrictions which will also be well publicised via NOTAM, all tenants and aircraft owners will retain unobstructed access to the runway and taxiways throughout the event, so need not make special contingency plans of the type required in past years.

The Festival of Flight will include many family oriented ground activities and shows such as motorcycle display teams and vintage cars as well as giving a nod to the traditional air show event by presenting some of the more exciting and best loved air display acts. Don't expect an all-day air show as in past years, but do expect a similar feel and look for the event. We want this to be an event for the local community as much as for those further afield, so we will be offering tickets to Biggin Hill residents at a concessionary rate well before they go on sale to the wider public at the full posted price. More details to follow. Now where did I put that Sukhoi...?
